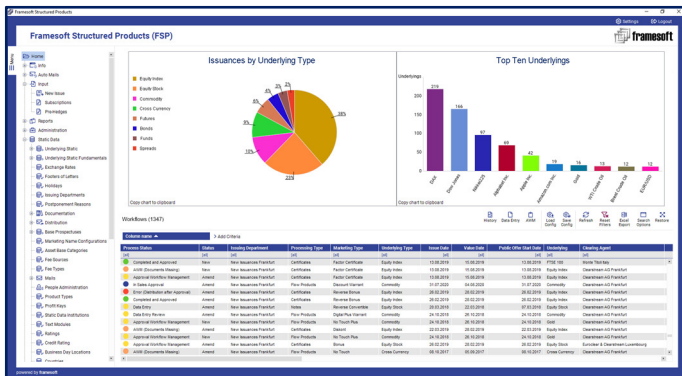

Completely Integrated Issue Workflow

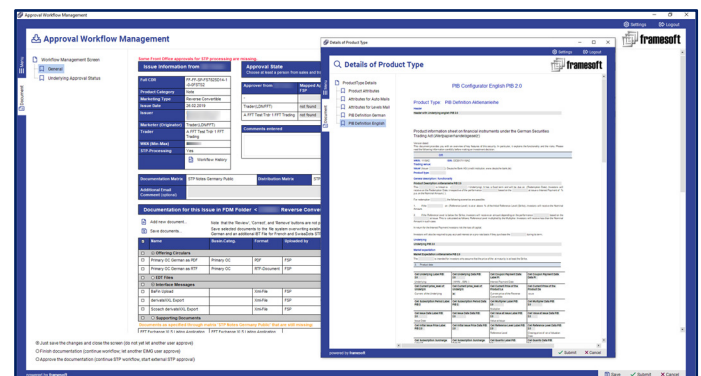
